ADULT MEMBERSHIP REQUIREMENTS FOR THE ORDER OF THE ARROW

Adult membership shall be persons over 21 years of age and they shall be selected as Candidates based upon the following:

Adult Leaders recommended by Units:

1. One adult may be recommended to the lodge each year for each 50 registered youth by the unit committee for consideration as a candidate for participation in the induction process provided the following conditions are fulfilled:
 - a. Selection of the adult is based upon their ability to make a contribution to the Order of the Arrow, and not for recognition of service, including current or prior achievement and position.
 - b. The individual will be an asset to the Order of the Arrow due to demonstrated skills and abilities which fulfill the purpose of the Order.
 - c. The individual has had 15 days and nights of Scout camping within 2 years prior to the recommendation under the auspices and standards of the Boy Scouts of America. These 15 days and nights must include one long-term camp (6 consecutive days) and at least 9 days and nights of short-term camping (overnight, 2 3, or 4 days).
 - d. The individual's membership will provide a positive role model for the growth and development of the youth members of the lodge.
 - e. The unit must have held a youth election in the current year in order to recommend an adult.
2. Adults with multiple registrations are eligible for recommendation only from their primary unit. The primary unit is the unit where the Boy Scouts of America registration fee is paid and membership card is issued.

Adult Leaders in Council and District Positions:

1. Recommendations shall be submitted to the lodge by the District Chairman, Council President, Scout Executive, or members of the professional staff.
2. All requirements set for adult leaders in units above must fulfilled, except 1e above.

Induction of adult members shall be at the discretion of the lodge staff and lay advisors committee.

Use the form on the reverse to submit your recommendations . The lodge meets in March, April, May, August, and October to consider recommendations.

A confirmation of receipt will be sent to the Village and person submitting this recommendation form. The confirmation **DOES NOT** mean the individual has been approved by the lodge.
